WHAT IS THE OREGON MEDICAL BOARD?

What is the Oregon Medical Board?

The Oregon Medical Board (OMB) is a state agency that licenses and regulates physicians in the State of Oregon. The Board's mission is to protect the public by ensuring that only qualified and competent physicians are licensed to practice medicine in the State. The Board accomplishes that by setting standards for medical education and training, assessing physician competence, and disciplining licensees who violate the Board's standards.

The OMB is comprised of seven members: four physicians and three public members who are not physicians. The Board members are appointed by the Governor and confirmed by the Oregon Senate.

What Authority Does the OMB Have?

The Oregon Medical Board has the authority to investigate complaints against licensed physicians. When the Board receives a complaint, it will review the complaint to determine if there is enough evidence to warrant an investigation.

If the Board decides to investigate, they will gather evidence and then make a determination as to whether or not the physician violated any standards. If the Board finds that the physician violated standards, it may take disciplinary action against the physician, which can range from a warning to revocation of the license.
